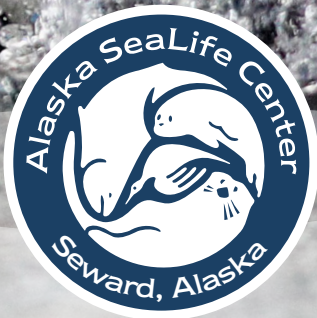

From the President and CEO

In 2021 we did our best to adjust to the new “normal” at the Alaska SeaLife Center. A year without cruise ships or in-person education programs left us wondering how we would continue our mission to educate and inspire. While the year started with a lot of uncertainty, it ended with some very big accomplishments.

After years of hard work, planning, and supply-chain delays, our staff unveiled the new Rocky Coast Discovery Pools in Spring 2021. The team began developing this new exhibit in 2017 by visiting and studying twenty touch pools at accredited Association of Zoos and Aquariums facilities in the United States. Installing the new interactive design required a complete demolition of the original touch pool, built in 1998 when the Center first opened. The new experience is a whole new way for our educators to inspire guests.

Later in the year, we welcomed Dr. Wei Ying Wong as our very first Chief Science and Education Officer. Dr. Wong will lead and further enhance the collaboration between our teams of educators and scientists for expanded mission impact. Creating this new senior leadership position demonstrates the Center’s commitment to build upon our existing world class assets to advance the Center’s mission and expand scientific capacity to mitigate, respond, and adapt to the challenges of the new millennium.

In 2021 we saw our highest attendance numbers since 2018, despite the lack of cruise ships in Seward. A year that started with a lot of uncertainty has left us with a new feeling of renewed hope. Hope for the future of the Center. Hope for the animals that we can continue to protect. Hope for connecting more people than ever to the ocean.

I’m so proud of this team that continues to challenge themselves to find innovative ways to share and advance our mission of promoting understanding and stewardship of Alaska’s marine ecosystems by generating and sharing scientific knowledge. On behalf of the board, staff, volunteers, and members of the Alaska SeaLife Center, I thank you for your support and encourage you to join us in our journey to protect marine wildlife.

2021 Highlights

COVID-19 CONTINUES

The COVID-19 pandemic continued into 2021, but after the incredible success of the “Save the Center” campaign in 2020, the Center was able to stay open for all of 2021. ASLC followed CDC guidelines and required masks for staff and visitors when it was recommended to do so. Attendance ended at the highest the Center has seen since 2018 with over 166,000 guests despite the absence of cruise ships in Seward.



VIRTUAL ALASKA MARINE GALA

The Alaska Marine Gala went virtual for the first time ever in February 2021 due to the COVID-19 pandemic. The program streamed on Facebook and YouTube and had over 350 viewers during the live stream. The video gathered over 5,000 views over the course of the year, and Jeff Corwin even delivered a message to viewers. This was a record-breaking fundraiser, raising over \$285,000!



ROCKY COAST DISCOVERY POOLS OPEN

The Rocky Coast Discovery Pools officially opened in Spring 2021. The team at ASLC began developing this new exhibit in 2017. Installing the new modern and interactive design required a complete demolition of the former touch pool, originally built in 1998, and features a new 1,100 gallon exhibit with six pools and three small feature tanks.

FIRST CHIEF SCIENCE AND EDUCATION OFFICER HIRED

The Alaska SeaLife Center launched a national search for a Chief Science and Education Officer in June of 2021, and selected Dr. Wei Ying Wong for the role in November 2021. As the first executive to serve in this newly created senior leadership position, Dr. Wong will lead our team of educators and scientists in a collaborative commitment to enhance ASLC's scientific capacity and mission impact.



WILDLIFE RESPONSE PROGRAM

The Wildlife Response Program rescued, rehabilitated, and released seven harbor seals during 2021 and one found his home at the ASLC after it was determined that he couldn't be released. Additionally, the program admitted one ringed seal and one harbor seal that did not make it due to health complications. Two stranded sea otter pups were admitted, and after recovering and getting a clear bill of health, both were transported to SeaWorld San Diego.

EDUCATION SHIFTS TO VIRTUAL OUTREACH

The education team geared up for a year of providing free virtual programming, thanks to donors who sponsored the launch of two virtual education programs. SCIENTIFIC RESEARCH

The Chiswell Project, funded by grants from NOAA entitled, "Long-Term Monitoring of Trends in Steller Sea Lion Behavior, Diet, Vital Rates, and Demography within the Endangered, Western Distinct Population Segment," is now in its 24th year. This project is ASLC's longest ongoing research study and has trained more than 50 interns and early-career scientists. Seabird-related remote monitoring studies have also spun off from this work.



PARTNERSHIP TO RESPOND TO OIL SPILLS

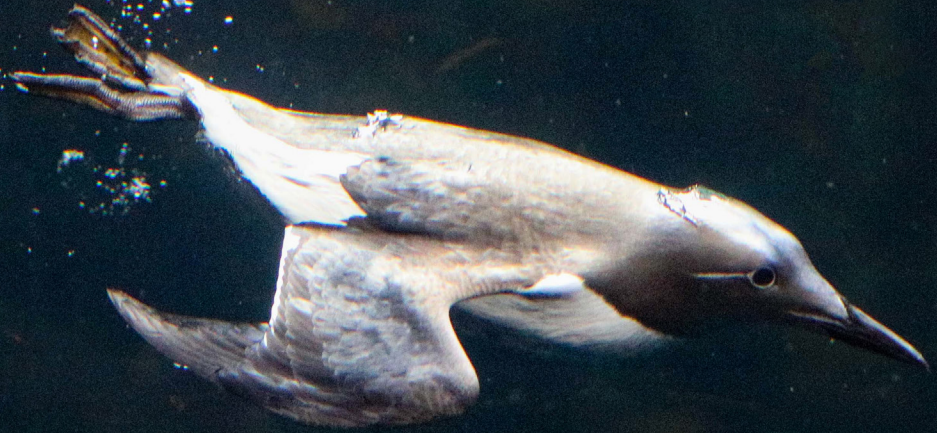
The Alaska SeaLife Center and International Bird Rescue (IBR) finalized a mutual services agreement to work together and train, prepare, and respond to wildlife impacted by oil spills. ASLC and IBR have a common mission of helping animals in need and after two years of strategizing, have finalized an official partnership to strengthen oil spill response.



ALASKA ANIMAL RESCUE: SEASON 2

Season 2 of Alaska Animal Rescue aired September 1, 2021 on Nat Geo WILD and Disney+. This season had nine episodes featuring ASLC alongside two other Alaskan animal care facilities as they cared for animals in need.

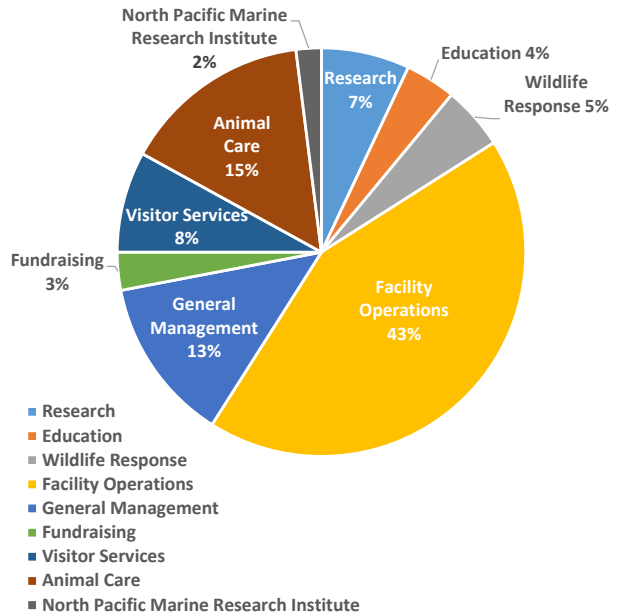
